TERMS AND CONDITIONS GOVERNING LOCKER FACILITY OF VIBOR BIKAS BANK LTD.

The lessee will have no right of property on the locker but only the right to use it. Similarly, he/she will have no right to sublet the locker or any part of it.

The bank will not hold any responsibility for partial or complete loss/destruction of any thing kept in the locker.

The Lockers fee are payable in advance and the Bank reserves the right of refusing the lessee access to the Locker if such fees are not paid when due.

The customer is fully responsible for the key and password of their lockers.

The locker should be used for the deposit of documents, jewellerys, or other valuables and not for any harmful/ destructive/perishable/illegal/dangerous goods.

The bank may terminate and require the surrender of the safe and its keys at any time by a notice mailed to the last known address on the bank's record. The bank may forcibly open any safe with the prior notification to the lessee and remove the contents thereof in former case and incase he/she does not pay the locker charges for a period of two years.

Incase of safe taken in the name of two persons, the locker will remain in control of each of them. Any of them may have access alone, can surrender the safe or appoint the attorneys without any liability to the other.

Only the person authorized on the records of the Bank is allowed access to the Locker.

Deputies or attorneys may be appointed by corporate, individual or partnership customers. However, such appointments must be satisfactory to the bank as well. In case of corporations, the appointment must be made clear by the resolution of the board of directors and in case of partnership/individuals, it must be in writing. Until the receipt of written notice regarding the revocation of any power of attorney or deputy, appointment or notice of the death or legal incapacity of the customer/s, the action of the bank shall rely upon the former information supplied to the bank.

The bank should be immediately informed, in case the lessee or customer loses the key of the locker. The bank will charge the applicable charges for replacement keys and changing the lock.

The bank should be notified immediately of any changes in the address of the customer or the authorized person to have access to the locker.

The lessee may terminate the service by giving fifteen days' notice in writing prior to the date on which the agreed period of locker facility terminates. The bank has right to consider that a safe has not been surrendered until it has been emptied, the keys returned and the bank notified of the surrender in writing.

I/We have read all the above mentioned terms and conditions and agree to abide by all present and future terms and conditions governing the Safe Deposit Locker facility of Vibor Bikas Bank Ltd.
